

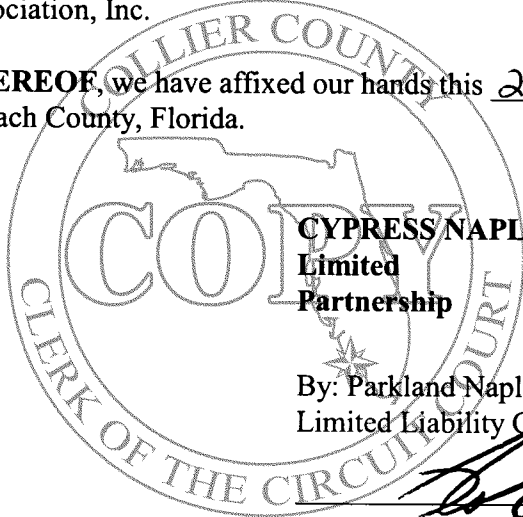

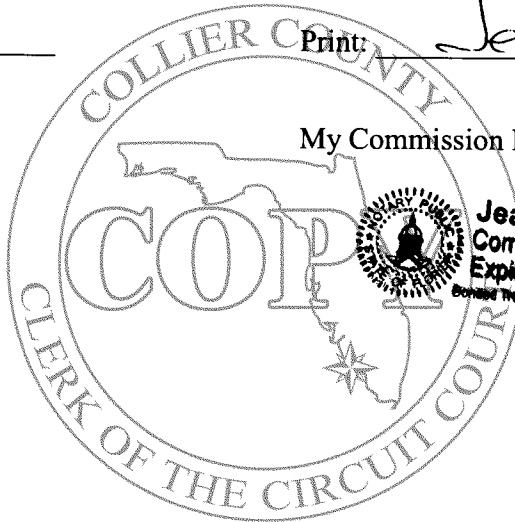

AMENDMENTS TO THE DECLARATION OF
COVENANTS, EASEMENTS AND RESTRICTIONS FOR
POSITANO PLACE AT NAPLES MASTER ASSOCIATION, INC.

NOTE: NEW WORDS INSERTED IN THE TEXT ARE UNDERLINED AND WORDS DELETED ARE LINED THROUGH WITH HYPHENS

1. *Amendment to Article VIII of the Declaration of Covenants, Easements and Restrictions creating a new Section 8.16 as follows:*

Section 8.16 Vehicles and Parking.

Parking is prohibited anywhere on the Common Areas or Common Properties other than designated parking spaces. No boats, construction vehicles, trailers, recreation vehicles (RV's), trailer homes, mobile homes, or commercial vehicles are permitted anywhere on the Common Areas or Common Properties except as specifically permitted herein. Commercial Vehicles shall be defined as vehicles with any lettering indicating a company, business, service or product and/or vehicles with a specific commercial purpose (i.e. tow truck, taxi cab, etc.). Police vehicles and governmental agency vehicles shall not be defined as commercial vehicles.

Notwithstanding the foregoing, commercial vehicles that need to enter the community for valid business purposes may do so but they may not be parked on the Common Areas or Common Properties overnight.

No inoperable vehicles shall be permitted anywhere on the Common Areas or Common Properties for longer than forty-eight (48) consecutive hours. Repairs to a vehicle (other than changing a tire) shall not be permitted anywhere on the Common Areas or Common Properties.

The Board of Directors shall have the authority to assign parking spaces and may promulgate further rules and regulations governing the assignment system to be used, the number and location of spaces available, the costs involved to the recipients of assigned spaces and setting forth penalties for any violation of the parking policy. The penalties available to the Board for parking violations may include towing of vehicles at the violator(s)' expense.
